I (we) certify for the attention of the Austrian Federal Ministry for Labour and Economy,

- that I (we) will not re-export the equipment, material or related technology or any replica thereof to third countries without the approval of the Austrian Federal Ministry for Labour and Economy (see contact details in letterhead). However, no approval is necessary for the re-export to the following countries: Australia, Belgium, Bulgaria, Canada, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Japan, Latvia, Lithuania, Luxembourg, Malta, Netherlands, New Zealand, Norway, Poland, Portugal, Romania, Slovakia, Slovenia, Spain, Sweden, Switzerland including Liechtenstein, United Kingdom and the United States of America.
